### Introduction


This document describes new functions in Wave Releases on an ongoing basis. Major changes are explained separately, smaller points and bug fixes in bullet points.

Non-critical bugs and new functions are rolled out with new Wave releases and may still need to be set up through configuration.

Security Fixes and Critical bugs are only implemented inside the **last three** Wave versions, **older versions are out of maintenance.**

#### SP-11046338 – Upgrade to MFA Function

With v2.17 we introduced the possibility of Multi Factor Authentication.

In 2.18 it will be possible to configure how many bad attempts are possible before a token-link gets invalid. There is now a counter which counts how many times the link is being used in a wrong location, like wrong Computer or wrong Browser, and if it reaches the configured amount the link will be deactivated. The default value for this is 3.

# SP-11048682 - Logicbuilder access for Cloudflow file information

With this release it is now possible to access coudflow file information which are available in a job. If you know the src and the jobid in the Logicbuilder Script you can get all files which have a certain Filecategory from the Cloudflow folder. For each of those files you can then access several information like the fileid.

# Version 2.17 – Important Changes

#### Proofscope Viewer gets user's name and email separately

Originally Proofscope displayed names and mail addresses together in commentaries. We changed this logic so that Proofscope only shows names, mails stay in background.

If wished Proofscope can be configured like before on request.

#### New rights for system log and mail log

Originally there was only one right "log" to see Mails in History tab, General Mail log and General System log. The last two ones are usually disabled for users by another right. But since some Customers need access to General Mail log but are not allowed to access General System Log this had to be divided.

Therefore, the right "log" was replaced by "mail-log" (Mail in History Tab and General Mail log) and "sys-log" (General System log). This means that after the update it needs to be checked and configured who should have access to those two areas in wave.

#### **PHP 8 Compatibility**

We updated Wave to the latest release of PHP8 to provide our customers the best standard in safety and functionality.





#### **Single Line Edit**

With the new single line edit feature it is possible to edit a job directly from the job list. There is a new right for this in the configuration it can be defined which fields are available in there.

When a user selects one line in the job list the single line edit form can be opened. There will be a popup which is similar to the Multi Edit Job Form, but the selected job data will be displayed in there and can be changed directly.

Cascading Fields will be excluded from this feature since the cascading is not available in here. User Rights will be checked as usual. Like Multi Job Edit there is a new Main menu option where the Admins can configure the order of the fields in the Single Line Edit form.

#### MFA - Multi Factor Authentification

With 2.17 Wave will have integrated the possibility to use optinal for groups an MFA. First factor is still name and password, the second one is an E-Mail which contains a token for the user

This new feature improves our high standard in Security but is still flexible to use it only for Groups where customer really needs it.



#### **New Automate feature (copy-fit)**

We extended our Automate Module which is based on Chili technology. The new feature allows end user to use a pre-defined artwork template. The artwork template itself needs to be created by an agency (e. g. SGK), not provided by 5Flow but we can connect with template building agencies.

The use case is various based on customer needs. As a case it's possible to check if your pack copy content - provided in a predefined Excel file - fits on your package size. You are also able to generate

With the new integration it is possible to open chili projects from the main menu in Wave without a connected Wave job needed.









Multiple jobs edit in the list of project items

It is now possible to use Multi Job Edit also inside the project layer directly, not only in job lists.

New Service to remove password for users who should be forced to use sso

In Groups you can now define if users should be forced so login via SSO. A service that runs every minute deletes passwords of concerned users, so that it's not possible anymore to login via Password.










New Icon for custom Tabs in Wave

There is a new drop icon available for customer specific tabs.

Conditions can have up to 100 items

The APL conditions form has been extended to allow up to 100 entries.

New option in devtools to update multiple language variables at once



Update File List View: Project Files

Now possible to search for files which are saved in projects, in v2.16 it was only possible to search for files in Wave IDs.

New Dashboard configuration options

With v2.17 it will be possible activate or deactivate Dashboard / Welcome Page separately as config variable



Firstnames, Lastnames or birth years are not allowed in the password

There was a problem with not allowed terms for passwords. If forbidden terms like Lastnames were used it was counted as failed login attempt. This is now fixed.

Send new username sends now the correct username when it was changed

In the function "Send new Username" there was a bug which caused that old names (instead of new ones) were sent out via mail; this has been fixed now.

Sorting of file upload categories alphabetical

File categories are now in correct alphabetical order.

File category is not immediately displayed during upload

After the first upload of a file in File Tab section the File Category was missing, user had to refresh to show it again. This is now fixed and comes automatically after upload.



o Fix issues with closing flags which have been activated multiple times

Some customers had problems with flags which have been opened and closed multiple times, this has been fixed now.

Wrong mouseover ins job history for status changes

Some customers had problems with wrong mouseover popups in the history tap for status changes, this has been fixed now.

o Remove Jobfields from joblists if a read right has been added

Some Customers had problems when taking away edit and read rights from a field in the "search result colums", the entry was still visible in the job list bar but not in the search results columns. Jobfields will now be removed from the columns, if a user is missing the needed right.

Check delete right, instead of insert right, to be able to delete global views

Some Customers had problems that wrong persons without the correct rights where able to delete Global Views, this has been fixed now.

Create JobField Button now depends on the insert right

For safety reasons some internal rights have been optimized.



Display JobFlags in archived jobs

Some customers had problems with archived jobs which had been cancelled before. The Cancelled flag disappeared once the job is moved to Archive. This has been fixed now.

o Better display of workflow icons in subscribed jobs tab

Display optimization in subscribed jobs tab.

Fix errors while validating email addresses in WAVE

Some Customers had a copy / paste error which has been fixed now.

Show info icon with descriptions also for bigint fields

Some Customers had problems with updating the description of BigInt types fields (i-Buttons), this has been fixed now.

Fix redirect errors on the dashboard

There was a clean-up of some errors in syslog.

Fix icon sizes for sgk-black design

Fix of a broken icon in HubX menu bar



- Jobfield aliases are checked if they already exist in the current mandator, duplicates will be blocked
- Duplicates are now blocked with error message.
- Sending correct usernames also after updating them

Some Customers had a problem when sending a new password to a user which generated the email with the value for username identical to the password. This problem has now been fixed.

Show project files also properly for archived jobs

Some Customers had a problem that files in projects have not been shown in archive. This has been fixed now.

- Better error reporting in multi-jobs-edit from logicbuilder validation
- Configurable Event when adding new countries to an apl

Some Customers had problems with timings when adding new groups to an APL. This is now fixed by a configurable event.

No Content Needed should not fill two fields in Nutri Score

When filling the Nutriscore table in Phrase it is possible to leave fields open which leads to an automatic filling with "No Content Needed". For certain fields this can be a problem since they are essential for calculation. This has now been fixed, they are not filled automatically anymore.



Fixed issues in picker search with special characters

Some Customers had problems with Picker fields, sometimes if users have chosen several values and then used the search function the original values got emptied. This is now fixed.

Reactivation of groups

In v2.16 there was a problem with the re-activation (after a deactivation) of groups. This led to an error message and the group could not be reactivated. This is now fixed.

- Reduced PHP warnings regarding unknown jobfield aliases
- For inserting new flags users now need the corresponding insert right

Key Users with the reading right for flags were also able to create new ones. This is now changed by a new right, so it can be separated.

Remove g from fields which have "gewicht" as alias

Some Customers have "gewicht" as an alias, this led to a problem that added a "g" in the keyword. This has now been fixed.

# Version 2.16 – Important Changes

 With Wave 2.16 the old reporting feature is not available anymore. Reports are only available with Evaluate Products which can also be implemented directly into Wave Systems





#### **Optimized Filelist View and Download**





- It is now possible to Search for Uploaded Files directly with an expanded Search function
  - Direct search for file names
  - Search for Wave Jobs with result of file names for each Wave ID
  - o Direct downloads of single files for Documents and Dalim / Proofscope PDF
  - Mass download via Shopping Card functions for Documents
  - Only available for files in Wave IDs, not for Project Layer shared Items





- o Show error message when trying to upload a file which is bigger than the max upload size
  - Automatically activated with 2.16
  - o Before Upload would just break without warning and file could be missing without notice
- Configurable Time zone for every single Mandator






### 2.12 Multi Job Creation

With this function it is possible to create several jobs automatically from one workflow in another. In a project you can have several child jobs related to one parent job. If so you can use this function to create the child jobs automatically by pressing a button, as a base you select a condition for that.


An example: You have a parent job for a Master Design and adapt 4 Language Versions out of it. Wave knows the field for languages and splits this field into 4 and creates the 4 Jobs with all informations and attaches it to the Design Workflow.





# 2.12 Direct Integration Evaluate Dashbaords

This feature connects a Wave instance directly to Tableau so that Tableau dashboards and views created with 5Flow can be displayed in the Wave Portal. The wave user managment can be used to limit the access.

One of the main focus for version 2.12 is a big package of security fixes concerning Wave Code and Dalim PDF viewer.




# New optional Invite Logic (2.9)

With the new (optional) invitation logic, it is still possible to invite groups. However, tasks are now assigned to a specific person in the group. You select your group on the dashboard via dropdown and can thus see all tasks of this group. Now you can choose whether all tasks of this group or only your own tasks are displayed.

This group is managed by the client with its own group email. It is now possible for either a team leader to assign the task or for a person in the team to assign the task themselves. These possibilities are bound to the rights of the users.

The big advantage is coordinated work in teams and a significantly reduced data volume for the system.






#### **New Dashboard**

The new dashboard provides an overview of all tasks that a user currently has. A distinction is made between APL tasks, flag tasks and status change tasks. In addition, the substitute regulation and the email list can be found here. The overviews can be set and individualised as usual under Options.

Basically, there are 3 circles for APL and Flag, which subdivide the tasks again according to the urgency / due date of the task. The status changes show the numbers of the statuses without urgency.

It is also possible to display all APL, flag and status change tasks independently of the circles by using the buttons below.



### **New Dashboard**

In this view, all open tasks are shown, but they are pale and not selected. Therefore, no search result is displayed. But you can still see how many jobs are currently available for processing. From this view, you can now compile results as you wish or display all the respective tasks via "Show all".




Here is an example: Late APL tasks and status change tasks in status 12 have been selected. Both are highlighted and no longer pale.





# Due date column

Depending on the dates entered in the job form, these are displayed in the milestones:








### Due date column

One can select the column "Milestone due date" in the column selection. In the job overview, the field is then marked in colour if a due date from the milestones has been exceeded (red) or is due (orange):





### New Joblist Header

To improve Wave, a new summary view has been introduced above the job list. At a glance, you can see which jobs are overdue in which statuses; the information comes from the appointments, as with the due date column. This list can optionally be activated and deactivated in the settings:



#### Overview



If you filter your list, e.g. by brand management or a specific job, you will only see the overdue jobs for that selection.







# Input fields Columns

In addition, input fields are now displayed in the job lists below the column names that you have set up as columns. Within these search fields you can "start" the search in two ways:

- o On the one hand, a search term can be entered in the input field and accepted by pressing the "Enter"/"Return" button.
- o On the other hand, the search can be applied by clicking the "Search" button in the search panel.

To delete a search term, either the "Show all" button can be pressed or the search term can be removed from the input field and accepted by pressing the "Enter"/"Return" key.



The input field is only displayed if the "Search field" flag has been activated in the job field and the user has the right to operate this field. If a job field is "searchable" and represents a column in the list, it is not explicitly displayed in the search panel below the filter panel. This means that if one has set up a column that can be searched directly, it will no longer appear in the normal search option.





# New Add Revisor Function

The optimised Add Revisor function has been given a compact menu, where **Filter / Group Filter** and **User Selection** can now be used to filter more conveniently, the selections are cascading, i.e. dependent on each other.

The Group Selection contains all users.

With **Add External Users**, people can be freely invited to the APL by e-mail address. A link will only take them to the APL, e.g. a print shop or institute.

As originally, it is possible to classify an added person in the position and to specify the days for checking.




### Global Search

Up to version 2.5, a search could be started without specifying values in the search fields Search terms. This resulted in all active and archive jobs being searched and displayed.

On some systems, performing this search led to long waiting times or even memory overflows.

We have therefore fundamentally redesigned the global search.



The search has also been extended with pagination for extensive search results.




Picture: Pagination and sorting options within the job list



# E-mail dispatch in case of representation

In the event of a substitution, Out of Office and Back in Office mails are sent automatically. This informs substitutes that you will take over all tasks from then on.







# **Export List via E-Mail**

The list export in the overview list has been extended.

In addition to the option of direct download, there is now also the option of sending by e-mail.

# 2.9 Extension of existing functions

In Release 2.9, development was primarily focused on improving system performance. The database configuration, the table structure and the use of the memory cache were optimised. In addition, existing functions were expanded:

#### **RIGHT TO ACCESS GROUP RIGHTS**

There is a new right that prevents users with editing rights for groups from also accessing the rights of these groups. This is necessary to ensure that only authorised persons can access and edit the rights of a group.

#### **DEFINE MANDATORY FIELDS FOR STATUS CHANGE "BACK"**

Until this function was improved, the mandatory fields were only displayed during the status change if the target status was greater than the current one. Now, mandatory fields are always checked when the corresponding status is reached.

#### ADD CC-E-MAIL LIST IN EVERY E-Mail

This function offers the possibility to automatically add a list of recipients at the end of the e-mail. All users are displayed with their first names/last names and e-mail addresses separated by commas (in one line) or one after the other (each in a new line).





### **ICON PICKER**

Multiple selection of icons/pictograms/symbols and display on the job form.

This new function enables the selection of any symbols within a selection list within the portal

After you have selected the symbols and saved the job, they are displayed as symbols in the job form.

The selection of the displayed symbols is done via the General Files in the Home menu.

Within the customised main directory there must be a directory with the name ImagePicker. Within this directory, another directory is created which must have the same name as the code you have chosen for the selection list.

Within this directory you can upload all the images you want to use for the picker list, provided you have the appropriate rights


Picture: Selected icons within the job form



## Standard filter job list

Standard filter in the "Filter" area of the job list

With the help of the customer-specific configuration file, standard filters can be defined for all order types of 5FLOW.



These filters represent the standard fields so that the user can quickly get to frequently used search criteria.

No individual default filters can be set. The standard filters are displayed to all users in the filter area.

## **Shopping Card**

When Shopping Card is activated it appear on the upper right as icon. In all jobs in documents it is possible to mark all files or single ones and add them to shopping card. When needed user can open the shopping card and see list of jobs, single ones can be deleted here directly then downloaded or sent via Mail to users of the wave system.


